



**Pandung Subdistrict Municipality Announcement**  
**Subject: Policy of Not Accepting All Kinds of Presents and Gifts**  
**from Performing Duties (No Gift Policy)**  
**Fiscal Year B.E. 2569 (2026)**

The cabinet resolution on 8th December B.E. 2563 (2020) approved the National Reform Plan for the Prevention and Suppression of Corruption and Misconduct (revision) by specifying important reform activities (Big Rock). Activity 4 : Develop the Thai bureaucracy to be transparent and non-beneficial. Goal No.1 Section 1.1 Requires all government agencies to declare that all government officials do not accept all kinds of presents and gifts from performing duties (No Gift Policy).

Pandung Subdistrict Municipality is committed to opposing all forms of corruption and misconduct while striving to enhance morality, ethics, and honesty in the execution of duties. This drive for transparency within personnel operations aligns with the principles of Good Governance. Pandung Subdistrict Municipality would like to implement the Policy of Not Accepting All Kinds of Presents and Gifts from Performing Duties (No Gift Policy). It is a government agency where government officials do not accept all kinds of presents and gifts from performing duties. The administrators and personnel of Pandung Subdistrict Municipality strictly adhere to the following practices:

1. Do not seek to obtain presents and gifts or any other unlawful benefits.
2. Do not give and accept property or any other benefits as a result of performing duties before and after performing duties.
3. Do not consent or connive with family members giving or accepting presents, gifts, or any other benefits to work related people.
4. In cases where it is necessary to give or accept property or any other benefits according to morality or tradition, all must comply with the Regulations of the Office of the Prime Minister regarding Giving or Receiving Gifts of Government Officials B.E. 2565 (2022) and the Announcement of the National Anti-Corruption Commission on the criteria of Giving or Accepting property or any other benefits according to the morality of Government Officials B.E. 2563 (2020).

5. REFRAIN FROM RECEIVING AND GIVING "HONEST AND TRANSPARENT PANDUNG SUBDISTRICT MUNICIPALITY 2026

"All executives and officials of Pandung Subdistrict Municipality shall jointly perform duties, based on fairness and transparency, as role models for refusing to accept gifts, souvenirs, and all forms of benefits from job duties."
